Meeting noted its dissatisfaction with the refusal by Council to reply to these questions, and noted that the matter would now be referred to the relative State Minister.

Chairman also reported on a question from the floor and tabled the question which was concerning the deletion of the wind powered generator at the Regional Aquatic Centre Project. Council undertook to respond to that question in writing.
